The method to be used to determine the order of priority in which each of the persons interested in purchasing any of the specified residential properties may select the residential property that the person wishes to purchase: 將會使用何種方法，決定有意購買該等指明住宅物業的每名人士可揀選其意欲購買的住宅物業的優先次序：

The Vendor will first use balloting to determine the order of priority. After completion of the balloting and selection of the residential properties by the eligible persons, the order of priority in the selection of the remaining residential properties, if any, will be on a first come first served basis. In case of any dispute, the Vendor reserves its absolute right to allocate the specified residential properties to any interested person by any method.

Details of balloting are as follows:-

1. Interested person(s) ("**Applicant**") shall submit an Application Form together with the following items attached thereto:
 - (a) a copy of the Applicant's H.K.I.D. Card(s) or Passport(s) or a copy of Business Registration Certificate; and
 - (b) one cashier order in the sum of HK\$300,000 made payable to "Mayer Brown JSM" to the Sales Office in person (or by his/her/its/ their authorized representative(s)) on 12 November 2013 (Tuesday, from 10 a.m. to 7:00 p.m.), 14 November 2013 (Thursday, 10 a.m. to 7:00 p.m.) and 15 November 2013 (Friday, from 10:00 a.m. to 12:00 noon).
2. The number of Application Forms that the Applicants can submit is subject to the following limitations:-
 - (a) An Applicant is only allowed to submit a maximum of three (3) Application Forms.
 - (b) If an Applicant submits more than three (3) Application Forms, only the first three Application Forms will be entertained and any other Application Form submitted by that Applicant will be disregarded.
3. Each Application Forms must be attached with items 1. (a) and 1. (b). If the Applicant is successful in its/ his/ her/ their application for the purchase, the cashier order(s) will be used as part payment of the preliminary deposit for the purchase of the residential property(ies).
4. Applicants who have submitted Application Forms in accordance with paragraphs 1 to 3 above will be eligible for participation in the balloting. Notwithstanding the aforesaid, the Vendor reserves its absolute and final right to determine whether or not to accept an Applicant for participating in the balloting.
5. The balloting will take place at 3:00 p.m. on 15 November 2013 at the Sales Office. After the balloting has been completed, the results of the balloting, including "Application Number", "Ballot Result Sequence" and "Check-in Timeslot", will be posted by the Vendor at the Sales Office at or before 7:30 p.m. on 15 November 2013. Applicants will not be notified of the results of the balloting separately.
6. Applicants shall attend the Sales Office personally according to the "Check-in Timeslot" and bring along the original receipt of the Application Form. Applicant who arrives at the Sales Office at a time later than the "Check-in Timeslot" shall not be eligible to select and purchase the residential properties.

7. After verification of the identities of the Applicants, the Applicants shall proceed to select the residential properties which are available at the time of selection in the order of priority according to the “Ballot Result Sequence” and the Vendor's determination on the availability of residential properties for selection is final.
8. Applicant for each Application Form will be entitled to purchase a maximum of only one (1) residential property.
9. If Typhoon Signal No. 8 or above is hoisted or Black Rainstorm Warning is issued at any time between the hours of 10:00 a.m. and 7:00 p.m., for the safety of the Applicants and the maintenance of order at the Sales Office, the Vendor reserves its absolute right to suspend the sale of the residential properties, to close the Sales Office and/or to postpone the “Check-in Timeslot” of the affected Applicants to such other time and date as the Vendor may consider appropriate, provided that the “Ballot Result Sequence” of the affected Applicants will remain unchanged. Details of the arrangement will be posted by the Vendor at the Sales Office and the website designated by the Vendor for the development and the Applicants will not be notified separately.
10. If an Applicant has successfully selected any of the residential properties, the Applicant will be offered to view the selected residential property prior to entering into the preliminary agreement for sale and purchase. If the Applicant decides to purchase the selected residential property, the Applicant will enter into a preliminary agreement for sale and purchase of the residential property. Purchaser(s) in the preliminary agreement for sale and purchase of the residential property will be the same as stated in the relevant Application Form.
11. For those Applicants who have not purchased any residential property, their cashier order(s) submitted will be available for collection at the Sales Office by the Applicant from 18 November 2013 to 22 November 2013 (both days inclusive but exclusive of Saturday and Sunday) during 10:00 a.m. to 7:00 p.m.. If an Applicant authorizes a person to collect the cashier order on his behalf, he shall provide an authorization to the Vendor and the Vendor shall not be responsible for any loss or damage that may occur by such arrangement.

After the completion of the balloting and selection of the residential properties by the eligible persons, the order of priority in the selection of the remaining residential properties, if any, will be on a first come first served basis. Details of the first come first served method are as follows:-

1. Persons interested in purchasing must personally attend the Sales Office to select and purchase the residential properties.
2. The Vendor reserves its absolute right to allocate the specified residential properties to any interested person by any method.

賣方會首先以抽籤方式決定優先次序。當抽籤程序及合資格人士選購住宅物業完畢後，餘下的住宅物業(如有)將以先到先得形式發售。如有任何爭議，賣方保留絕對權力以任何方式分配任何住宅物業予任何有意購買的人士。

抽籤程序的詳情如下：

1. 有意認購的人士(「申請人」)須親身(或透過其獲授權人士)於2013年11月12日(星期二，由上午十時至下午七時)、2013年11月14日(星期四，上午10:00時至下午7:00時)及2013年11月15日(星期五，上午10:00時至正午12:00時)前往售樓處遞交認購申請表，連同夾附以下文件：
 - (a) 申請人的香港身份證或護照或公司商業登記證副本；及
 - (b) 一張港幣300,000元本票，抬頭人須為「孖士打律師行」。
2. 申請人可遞交的認購申請表數目受以下限制：
 - (a) 申請人可遞交最多三份認購申請表。
 - (b) 若申請人提交多於三份認購申請表，賣方只接受首三份認購申請表，而其他申請表將不被受理。
3. 每份認購申請表均須夾附1. (a)及1. (b)項文件。如有關申請人的認購申請成功，本票將會用作支付購買住宅物業的部份臨時訂金。
4. 已按上述第1段至第3段遞交認購申請表之申請人方可享有參與抽籤的資格。儘管上述條款另有規定，賣方保留最終絕對權力決定接受或拒絕任何參與抽籤的申請。
5. 抽籤程序將於2013年11月15日下午3:00時於售樓處進行。當抽籤程序完成後，賣方會於2013年11月15日下午7時30分或之前於售樓處將抽籤結果，包括「申請號碼」、「抽籤結果順序」、及「報到時段」於售樓處公布。申請人將不獲另行通知抽籤結果。
